Abstract

The purpose of this study is to test the viability of a series of test questions in determining trends in the education and lifestyles of Western composers between the Renaissance and the 20th century. The research consisted of acquiring the answers to a series of twenty questions for each of a set of twenty-five Western composers in the classical tradition ranging from Renaissance to 20th century. The data was then compiled and assessed to determine if any trends or commonalities could be found in the data set and to ascertain if the question set was effective at delivering useful data. The research questions proved to be a time-efficient and effective way to establish data points and trends in this data set. However, many of the questions showed no discernable trends. Research Concern




Research Questions


- Are there any common factors or trends in this data set regarding the education practices of these composers?
