"Finishing Well" is the title of Mr. Don Blose's presentation at the Academy luncheon on March 10 by Jack David Armold, Ph.D.

According to Mr. Blose, "Older adulthood is not just a time for relaxing and reflecting, it is also a time when senior adults become acutely aware of the best things in life and what is really important. Moreover, they have a strong desire to pass on the goodness that life has given them. When they pass on that goodness, they finish well."



"These senior adults inspire us and challenge us to achieve excellence," he continued, "they remain strong in their missions and true to their values. They continually charge forward. We both marvel at them and root for them at the same time. By their example, we also are encouraged to finish well."

I believe that Mr. Blose's presentation will offer encouragement to all our readers. His inspiring message will also serve as a fresh reminder that the latter stage of life is an optimal time for solidifying the legacy by which we wish to be remembered.

Mr. Blose is one of our newer members of the Academy. He is the Chief Executive Officer/Executive Administrator of the Spanish Cove Retirement Village in Yukon, Oklahoma.

Prior to his coming to Spanish Cove, Mr. Blose spent 26 years with the Oklahoma State Health Department, serving his last 12 years as the State's Immunization Director. As a public health official, he provided the leadership to improve Oklahoma's childhood vaccination coverage from 49<sup>th</sup> in the nation to 17<sup>th</sup> best. He also supervised the State's annual Adult Influenza and Pneumonia Vaccine Campaigns as well as the H1N1

Pandemic Vaccination Campaign in 2009. He adds, "Most of our State's senior adults needed little encouragement to get their flu vaccine. Oklahoma's senior adults are usually among the best vaccinated in the nation."

During his public health career, Mr. Blose was a national leader, serving many years as a board member and officer of the national Association of Immunization Managers and the American Immunization Registry Association. He has a rich history of service to his church, extended community, state, and nation. He was elected to the Yukon School Board in the 1990's and has continued to serve as a representative to the Yukon Schools Advisory Council, the Yukon Community Education Council, and the Yukon Public School Foundation for Excellence.

Mr. Blose is a graduate of Stillwater, Oklahoma, High School. He received his Bachelor's and Master's degrees in public administration from Oklahoma State University. He is also licensed as an Oklahoma Long-Term Care Administrator and currently serves as a Board Member for the Yukon Senior Housing Authority.

In conclusion, Mr. Blose wrote the following about his family members who currently live in Yukon: "I have an exceptional wife, Julie, and five children—two of them still at home. Julie is as pretty on the inside as she is on the outside."



Afghan-American author Khaled Hosseini's newest book is *And the Mountains Echoed*, a series of stories within a story as a father tells a folktale to his children, then gives his daughter to a wealthy man in Kabul. What follows is told from



multiple viewpoints, spanning more than half a century and shifting across continents. Hosseini is the best-selling author of *The Kite Runner* and *A Thousand Splendid Suns*. His third novel illustrates again and again how people's actions, even seemingly selfless ones, are shrouded in ambiguity.

On Wednesday, April 16, 2014, Peer Learning Network (PLN) Presents will host speaker Dr. Clayton Christensen, of Harvard Business School. The luncheon event will take place at the Jim Thorpe Event Center, Downtown Oklahoma City from 11:30 a.m. to 1:00 p.m.



In a 2011 poll of thousands of executives, consultants and business school professors, Christensen was named as the most influential business thinker in the world. Professor Christensen has authored eight best-selling books and more than a hundred articles, including the recently released, and New York Times best-selling, How Will You Measure Your Life? The Innovator's Dilemma received the Global Business Book Award as the best business book of the year (1997); and in 2011 The Economist named it as one of the six most important books about business ever written. Five times he has received the McKinsev Award, given to the two best articles published in the Harvard Business Review each year; and has received the Lifetime Achievement Award from the Tribeca Films Festival (2010). He has been featured twice (1998 and 2011) as the cover story in Forbes Magazine.

Clayton M. Christensen is the Kim B. Clark Professor of Business Administration at the Harvard Business School and is regarded as one of the world's top experts on innovation and growth.

Meet Ron and Yvonne Mercer

The Academy of Senior Professionals is blessed with a great membership of committed people who have notable service in their vocations and to our schools, community and to Southern Nazarene University.

Ronald L. (Ron) Mercer was born on a cattle ranch in Dewey County, Oklahoma near Taloga. He is a 2<sup>nd</sup> generation Nazarene. His mother was one of the charter members of the Camp Creek Church just <sup>1</sup>/<sub>2</sub> mile from their rural home. He graduated from Southern Nazarene University with a BBA degree and attended the Graduate School of Business at Harvard University. In 1988 his alma mater, Southern Nazarene University awarded him the honorary Doctor of Humanities degree.

Ron spent most of his business life at Xerox, which he joined in 1962 and remained in their employ until his retirement. He was the president of Xerox Canada, Inc., in Toronto, Canada, Senior Vice President for field operations in Rochester, New York, where he was responsible for all sales, service and administrative activities in the United States and was made an Officer of the Corporation. He also served as the District Manager for the Oklahoma District, Regional Sales Manager for the Mid West Region in Chicago and the Regional V.P. and General Manager for the Northeast Region in New York City. He managed the Oklahoma Offices from 1965 until 1970 when he first moved to Rochester, N.Y.

He and his wife Yvonne have four children, all talented with people skills, business acumen, musical gifts and ministry of service to others. They have 11 grandchildren and have been married 59 years. They live in Woodlawn Park and are members of Bethany First Church of the Nazarene. They formerly taught a Sunday School Class and have conducted lay retreats in 30 U.S. and Canadian Districts.

Yvonne has taught children in public school, Sunday school, and supervised children's departments in ministry of service where they have lived. After retirement from Xerox they moved to Bethany, OK where he and a partner, Gene Adams established a new funeral service, Mercer-Adams in Bethany which has grown during that time to become one of the premier full service funeral providers in Oklahoma.

Yvonne sang in the Bethany First Church of the Nazarene choir for 20 years and served as a small group facilitator at WOW, (Women of the Word) for several years. She and her siblings established the Edwards family music scholarship at Southern Nazarene University upon their parent's death and in their honor.

Ron served as an adjunct professor at SNU for two years teaching business strategy and business ethics. He currently serves on the board of the Bethany Improvement Foundation.

Governor Keating twice appointed him to serve on State of Oklahoma boards, first to the Oklahoma Futures Board which he chaired until his retirement and then to the Department of Human Services where he served as vice-chairman of the Commission until his 9 year term expired in late 2010. He also served on the board of First Fidelity Bank until his retirement in 2010. He continues to serve on The Children's Center Foundation, the Oklahoma Council of Public Affairs (a conservative think tank), Oklahoma Independent College & University Foundation and the Southern Nazarene University Foundation.

Ron has served both as chairman and vice chairman of the finance department of the General Board of the Church of the Nazarene for 13 years.

Ron and Yvonne are exceptional special event speakers and give superb leadership in everything they do. Again the Academy of Senior Professionals is so blessed.
